1. The following described Lakewood Forest North, Section Two, comprised of thirty-eight (38) residential lots and two (2) reserves, is hereby annexed as property subject to the Declaration and the jurisdiction of the Residential Association (as defined in the Declaration):

Lots 1-10, inclusive, Block 1; Lots 1-4, inclusive, Block 2; Lots 1-24, inclusive, Block 3; and Restricted Reserve "A" and Restricted Reserve "B", of Lakewood Forest North, Section Two, a subdivision of 10.0205 acres of land situated in the Antonio Schouten Survey Abstract No. 685, Harris County, Texas, according to the map or plat of record under Film Code No. 407143 in the Map Records of Harris County, Texas.

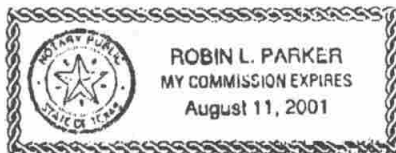
